You can search for network dentists before your benefits become active by visiting [Cigna.com](https://www.cigna.com).

- Select “Find a Doctor, Dentist or Facility”
- Follow prompts to search by type of dentist or by dentist name.
- When prompted to select a plan, choose “DPPO/EPO > Total DPPO”
